Artwork for a product sold in the UK

This example artwork includes all mandatory elements for a cosmetic aerosol sold in the UK. The elements mentioned in this guide is highlighted in green. Use it as an example when designing your artwork.

SUPER STRONG

HAIR SPRAY

250ml

SUPER STRONG HAIR SPRAY

SV: Hårspray med hård stadga som ger ett naturlig glans. Perfekt för att fixera frisyren för ett långvarigt resultat. Fräsch doft med inslag av persika och ros.
Instruktioner: Spraya med 20 cm avstånd till hårbotten. Undvik kontakt med ögonen.

EN: Hairspray with a hard hold that gives a natural shine. Perfect for fixing the hairstyle for a long-lasting result. Fresh scent with hints of peach and rose.
Instructions: Spray with a distance of 20 cm from the hair roots. Avoid contact with eyes.

SV Fara.
Extremt brandfarlig aerosol. Tryckbehållare: Kan sprängas vid uppvärmning.
Får inte utsättas för värme, heta ytor, gnistor, öppna lågor och andra antändningskällor. Rökning förbjuden. Spreja inte över öppen låga eller andra antändningskällor. Får inte punkteras eller brännas, gäller även tömd behållare. Skyddas från solljus. Får inte utsättas för temperaturer över 50 °C/ 122 °F. Förvaras oåtkomligt för barn.

EN Danger.
Extremely flammable aerosol. Pressurised container: May burst if heated. Keep away from heat, hot surfaces, sparks, open flames and other ignition sources. No smoking. Do not spray on an open flame or other ignition source. Do not pierce or burn, even after use. Protect from sunlight. Do not expose to temperatures exceeding 50 °C/ 122 °F. Keep out of reach of children.

Ingredients: Butane, Isobutane, Alcohol Denat., Propane, Solanum Tuberosum (Potato) Starch, Aluminum Starch Octenylsuccinate, Isopropyl Myristate, Polysorbate 20, Glycerin, Aqua, Hydrated Silica, Potassium Sorbate, Sorbic Acid, Parfum.

Regulatory guidelines for products sold in the UK with Paragon Nordic as the Responsible Person

This PDF outlines the additional mandatory artwork requirements for products sold in the UK. These requirements are in addition to the general labelling obligations that apply to all cosmetic products. Use this document as a guide to ensure your artwork design fully complies with relevant regulations.

In the **Elements** column, you'll find the additional mandatory labelling requirements specifically for products sold in the UK with Paragon Nordic as the Responsible Person. In the **Explanation** and **Examples & symbols** column, we clarify what each element entails and why or when it is required. Each of these elements will be reviewed by Paragon Nordic, unless otherwise specified.

If your product is an aerosol, wet wipe, or sunscreen, you will receive a separate PDF detailing the specific requirements for those categories. You will also be provided with a general guide covering the mandatory requirements for all cosmetic products.

Paragon Nordic reviews text only in Swedish and / or English. All other languages must be reviewed by the customer.
